"That the Survey Plan of subdivision relating to Scheme Plan of Subdivision No. W. 9253 of the Town of Titirangi Extension No. W. 54 of Subdivision of part Lot 9 on D.P. 39716, part Lot 1 on D.P. 16077 and part Lot 2 on D.P. 7589 being part Allotment 48 Waikomiti Parish comprised in Cs.T. 1859/40, ✓ 1910/32 1963/34 owned by Unit Subdivisions Limited be approved under Section 34 of the Counties Amendment Act, 1961, and under Section 40 the Rights of Way shown thereon conditional upon the granting or reserving of the easements referred to in the Memorandum of Easements endorsed thereon and subject also to the condition that no new buildings or hoardings shall be erected nor shall any buildings or hoardings be re-built or re-erected or be substantially re-built or re-erected on Lots 4 to 22 inclusive, Lots 71 to 89 inclusive and on Lots 91, 92, 93 and 98 within thirty-three (33) feet of the middle line of Daffodil Street (Lot 101) and also on Lots 93 and 98 within thirty-three (33) feet of the middle line of the adjoining Road Reserve (Lot 100) and also on Lots 79 to 83 inclusive within thirty-three (33) feet of the adjoining Road Reserve (Lot 102) these building lines being delineated on the plan and marked B.L.R. of the 22/7/65
